This Errata Sheet notes specific corrections to the Hudson Tunnel Project Final Environmental Impact Statement (FEIS; issued May 2021 as part of the Combined Final Environmental Impact Statement/Record of Decision and Final Section 4(f) Evaluation). These corrections are administrative in nature and do not include any substantive changes to the FEIS or the analysis therein that provided support for the Record of Decision for the Hudson Tunnel Project.

This Errata Sheet is being published both on the Project website and on FRA’s website, and FRA has also distributed this information to viewing locations and individuals who received paper copies of the FEIS.

CORRECTION TO CHAPTER 2: PROJECT ALTERNATIVES AND DESCRIPTION OF THE PREFERRED ALTERNATIVE

FRA notes the following correction to Chapter 2 of the FEIS, “Project Alternatives and Description of the Preferred Alternative,” to address a figure that was incorrectly omitted from the chapter.

- The chapter refers to Figure 2-3 on page 2-18, but the figure was not included anywhere in Chapter 2. This Errata Sheet refers readers instead to Figure S-3 on page S-9, which was intended to be identical to Figure 2-3.

CORRECTIONS TO CHAPTER 24: FINAL SECTION 4(f) EVALUATION

FRA notes the following corrections to Chapter 24 of the FEIS, “Final Section 4(f) Evaluation,” to correct mislabeling and incorrect placement of the following figures:

- Figure 24-3, following page 24-19, is now “Section 4(f) Historic Resources in New Jersey” (this figure was previously mislabeled as Figure 24-4).
- Figure 24-4, also following page 24-19, is now “Section 4(f) Historic Resources in New York” (this figure was previously mislabeled as Figure 24-5 and incorrectly placed following page 24-33).
- Figure 24-5, following page 24-33, is now “Hudson River Park Walkway and Route 9A Bikeway near West 29th Street” (this figure was previously mislabeled as Figure 24-3 and incorrectly following page 24-19).
